
FACULTY PROFILE: KRISTIN SCHULLER

ristin Schuller is an Assistant Professor in both the Department of Political Science and Public Administration and Master of Public Health Program. (See story, below).

Her research interests focus on organizational change and innovation implementation in health care settings, improving quality of care and patient safety related to reducing readmission rates and hospital-acquired conditions, and techniques to improve access and delivery of health care services to patients in rural areas.

Dr. Schuller received a B.S. in Health Services Administration as well as minors in Business and Environmental Health, and Psychology from Ohio University. She went on to earn her master's and doctorate degrees in Health Services and Policy and Management from the University of South Carolina.

After earning her Ph.D., she accepted a postdoctoral research position in the Center for Health Organization Trans-



formation at Texas A&M Health Sciences Center in College Station, TX.

The research she performed during her short tenure there included analyzing the success and sustainability of Studer Group's Evidence-Based Leadership Initiative in health systems, evaluating an ER triage program that diverts non-emergent patients to a rural health clinic, and assessing the impact on discharge phone calls as a tool to improve patient safety and quality of care and reduce hospital readmissions.

Two of her recent publications can be found in the *Journal of Communication* in *Healthcare* and the *Journal of Healthcare* Quality.

MPA IN NEW COLLABORATION WITH MASTER OF PUBLIC HEALTH

he Master of Public Health Program is a professional degree program offered by the School of Medicine and Health Sciences (SMHS). The MPH program has two specializations, one of which is Health Management and Policy. This specialization is offered through a unique partnership between the SMHS and College of Business and Public Administration (CoBPA), which was pioneered by SMHS Dean Joshua Wynne and CoBPA Dean Dennis Elbert.

This first-of-its-kind relationship at UND adds depth to the faculty expertise and course offerings available to MPH students and enriches the graduate programs in the CoBPA.

The faculty members serving in this specialization have joint appointments in both the SMHS and CoBPA. Currently, two of these faculty members are

on board: Kristin Schuller, MPH, Ph.D. (University of South Carolina) and Andy Hultquist, MPP, Ph.D. (The Ohio State University). A third member will join the faculties in Summer 2014.

The MPH specialization in health Management and Policy provides integrative, creative, and practical learning experiences that foster intellectual growth, critical thinking, and essential problemsolving and communication skills around issues of population health improvement.

Graduates are prepared to work in many regional, national, and international settings, including public health agencies, health care delivery organizations, health plans, non-governmental health organizations, academic institutions, and other government agencies.

ALUMNA PROFILE: AMANDA LICHT

graduated from UND in 2005 as a Political Science and Honors major, after completing my Honors thesis under Paul Sum and Mark Jendrysik.

I was accepted as a Presidential Fellow to the political science Ph.D. program at the University of Iowa, where I majored in International Relations and Political Methodology with a minor in Comparative Politics.

My dissertation work focused on how domestic political incentives of targeted leaders affect the success of friendly and hostile foreign policy tools, exemplified by foreign aid and economic sanctions.

Upon completion of my Ph.D. in 2010, I began a tenure-track position at



the University of South Carolina, where I worked for three years.

I recently began a new tenure-track job at Binghamton University, where the climate reminds me a lot more of home.

My work on foreign aid and leader survival has appeared in the *Journal of Conflict Resolution*, and I also have published on the interpretation of event history models in *Political Analysis* - the most cited journal in the discipline.

NEW MODEL UN GROUP FACES CHALLENGES OF CRISIS SITUATION

his past spring, PSPA students organized a trip to a Model United Nations conference in Chicago. UND students engaged in crisis negotiations with thousands of students from all over the United States.

Eight UND students attended the conference, including Sean Cano, Grand Forks; Ellyn Daniel, Grand Forks; Muneeb Hyder, Bismarck; Andrew Leizens, Grand Forks; Johannes Mahlum, Bismarck; Aaron Muz, Grand Forks; Patrick Wilde, Grand Forks, and Shelby Wood, Mandan, N.D. Accompanying the students was PSPA faculty member Brian Urlacher.

While many Model UN conferences provide simulations of the United Nations system, the ChoMUN conference was organized around a series of crisis situations that unfolded over the course of the three-day conference.

The crisis simulations focused on a range of topics, including international and domestic situations and contemporary and historical problems, such as the Congress of Vienna, Chicago City Council in 1919, the post September 11th decision-making process, and a simulation of efforts to respond to global hunger.

To prepare for the various simulations students sifted through hundreds of pages of briefing and background materials on the individuals they would represent and the environment in which they would be operating.

Junior **Shelby Wood** described the new organization as a needed outlet for "students interested in international relations, debate, public speaking, and meeting new people from universities across the world."

The trip received financial support from PSPA, the College of Business and Public Administration, and from the Office of the Vice President for Academic Affairs and Provost.
